This Cookie Policy explains how DKK Partners ("we," "us," or "our") uses cookies and similar technologies when you visit our website www.dkkpartners.com (the "Website"). It explains what these technologies are, why we use them, and how you can control them.

1. What Are Cookies?

Cookies are small text files placed on your device (computer, smartphone, or tablet) when you visit a website.

They are widely used to make websites work, improve user experience, and provide analytical information to website owners.

Cookies can be:

- Session cookies – Temporary cookies deleted when you close your browser.
- Persistent cookies – Remain on your device until deleted manually or automatically.
- First-party cookies – Set directly by our website.
- Third-party cookies – Set by third-party services integrated into our website, such as analytics or advertising providers.

2. How We Use Cookies

We use cookies for the following purposes:

- Strictly Necessary Cookies

These are essential for the operation of our website, including secure login areas and basic site navigation.

Without these cookies, certain services may not function properly.

- Performance & Analytics Cookies

These help us understand how visitors interact with our site by collecting anonymous data, allowing us to improve site performance and user experience.

- Functionality Cookies

These remember your preferences and settings to provide a more personalized experience.

- Advertising & Targeting Cookies (if applicable)

These track your browsing habits to deliver relevant advertisements across the web.

3. Third-Party Cookies

Some cookies on our Website are placed by trusted third-party services we use to enhance functionality, monitor performance, or deliver targeted advertising.

These include Google Analytics, LinkedIn Insight Tag, and other analytics or marketing providers.

4. Managing Your Cookie Preferences

You have the right to decide whether to accept or reject cookies:

- Via our cookie consent banner – You can manage your preferences when you first visit our site.
- Via browser settings – Most web browsers allow you to control cookies through their settings.

5. Legal Basis for Processing Cookies (GDPR & UK GDPR)

For visitors from the EU and UK, the use of non-essential cookies (such as analytics or marketing cookies) is based on your consent, which we request through our cookie banner.

Essential cookies are used on the basis of our legitimate interest in providing a secure and functional website.
